7.1 Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. SECTION 8: Exposure controls/personal protection
